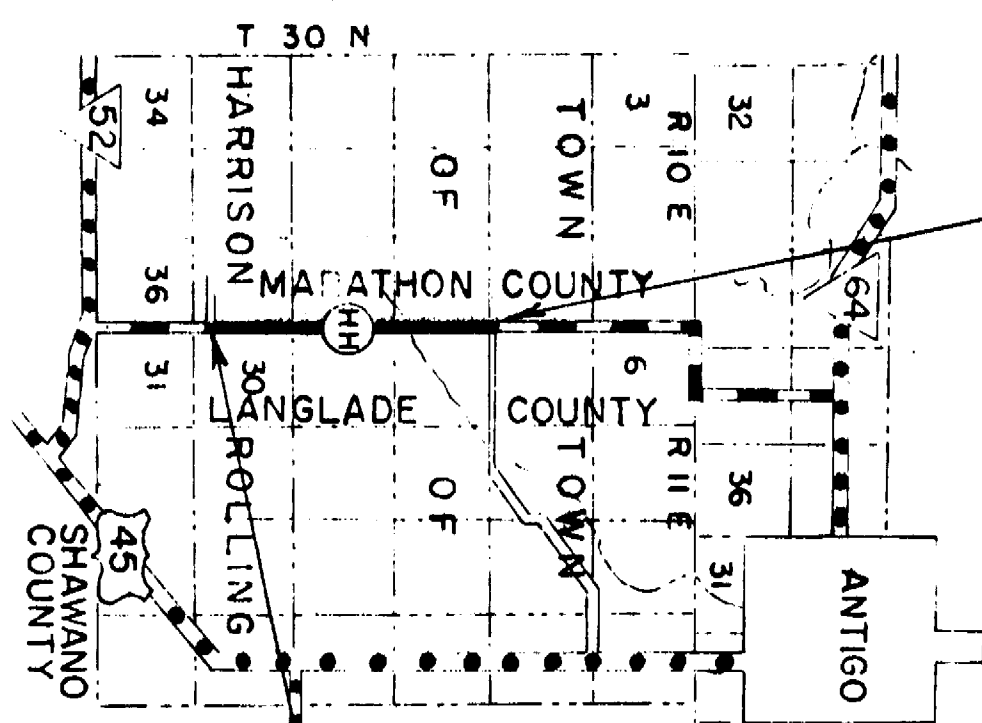
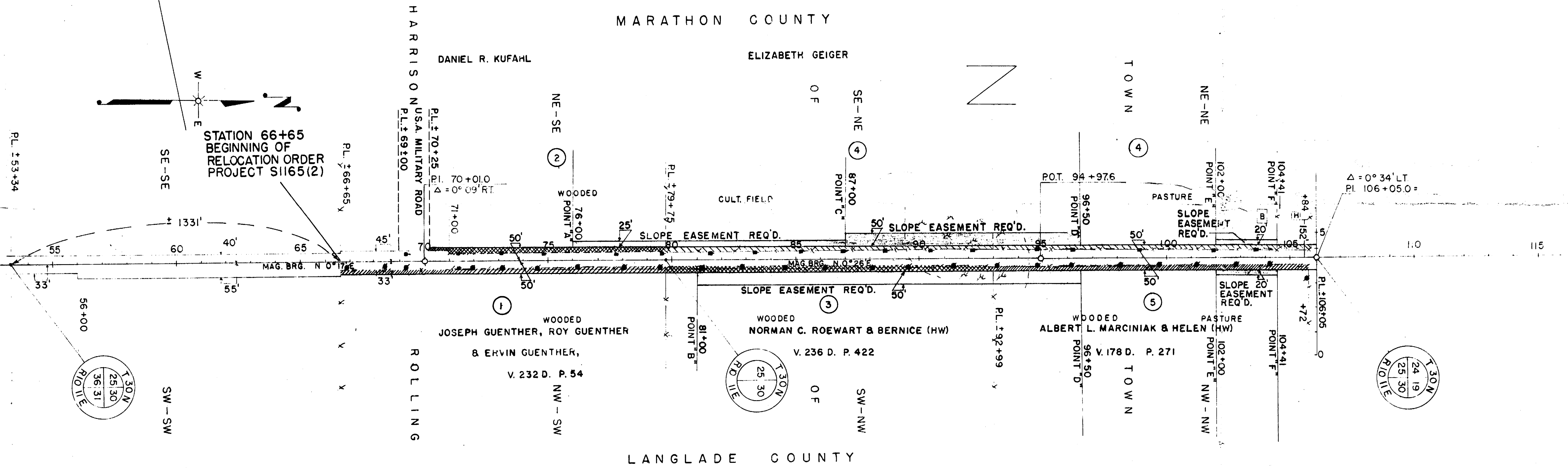

LOCATION SKETCH



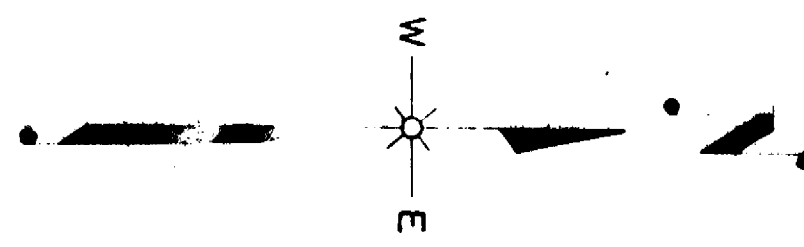

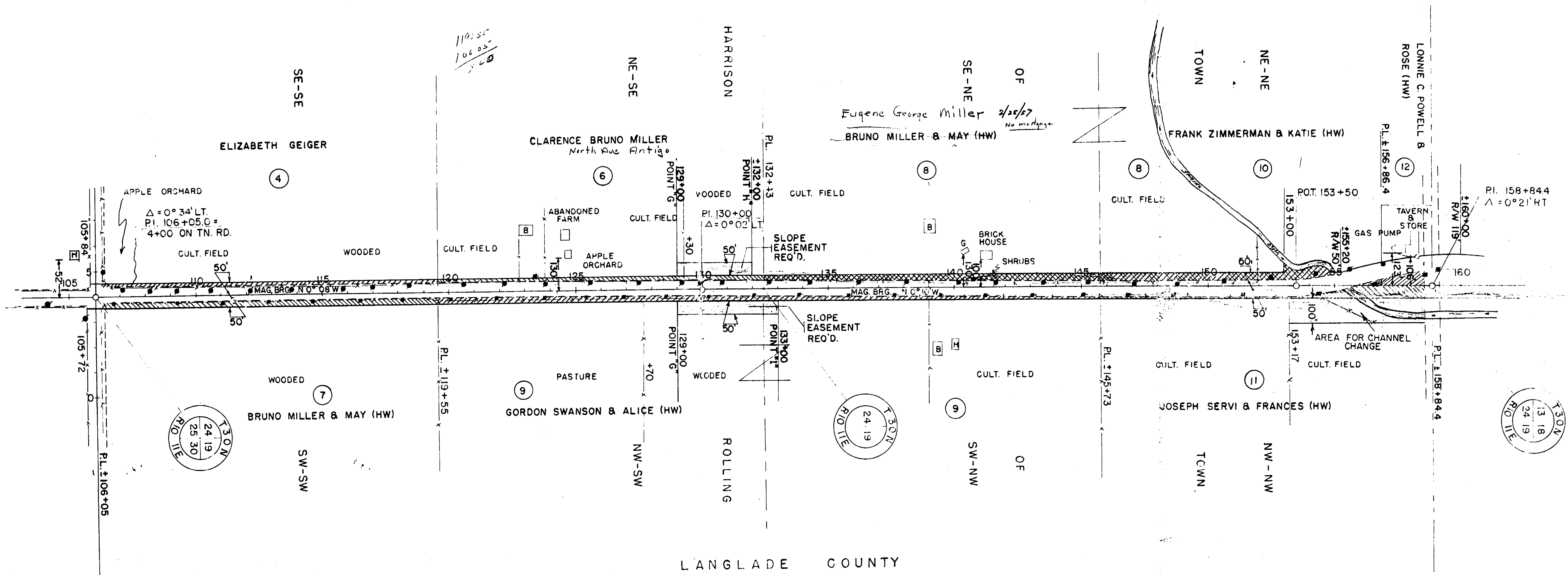

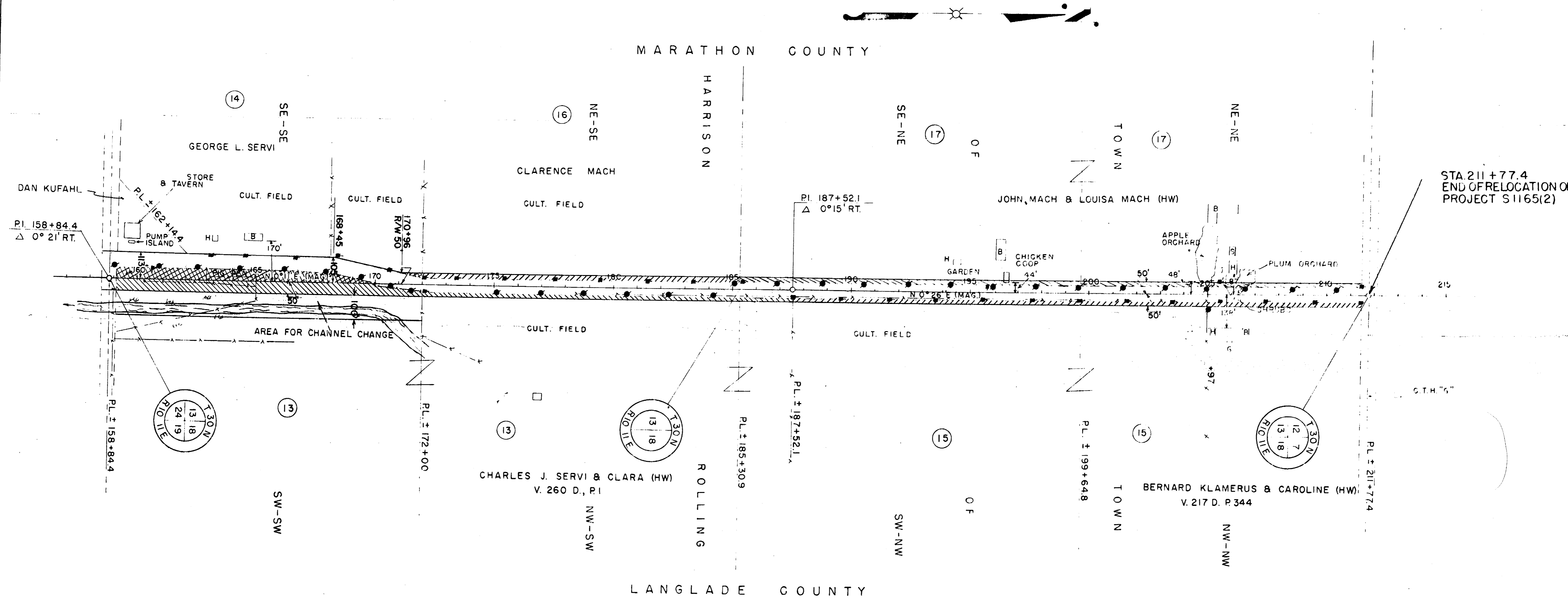
